What are we offering?

Offering:	Units (“ Units ”) of the Company, each Unit being comprised of one common share of the Company and one-half of one common share purchase warrant (each whole warrant, a “ Warrant ”). Each whole Warrant will entitle the holder to acquire one additional common share of the Company (a “ Warrant Share ”) at an exercise price of C\$0.25 per Warrant Share for a period of 24 months following the Closing Date (as defined below).
Offering Price:	\$0.18 per Unit (the “ Issue Price ”).
Offering Amount:	Up to 14,444,444 Units for gross proceeds of up to \$2,600,000 (the “ Offering ”). All references in this Offering Document to “dollars”, “C\$” or “\$” are to Canadian dollars, unless otherwise stated.
Closing Date:	Closing of the purchase and sale of the Units shall take place on or about July 26, 2024 (“ Closing Date ”), or on such other date as the Company may determine.

SUMMARY DESCRIPTION OF BUSINESS

What is our business?

The Company is engaged primarily in the business of evaluating, acquiring and exploring natural resource properties. The Company is not limited to any particular metal or region, but the corporate focus is on precious and base metals in North America. The Company's current focus is on two emerging discoveries in North America: (a) the Tombstone Project; and (b) the Cervantes Project.

The Tombstone Project is an emerging gold-silver discovery with high grade CRD silver-lead-zinc potential in southern Arizona, of which the Company owns and controls a 75% interest pursuant to a joint-venture agreement. The Cervantes Project is 100% owned emerging porphyry gold-copper discovery in Sonora, Mexico.

Recent developments

There are no material recent developments in respect of the Company that have not been disclosed in this Offering Document or in any other document filed by the Company in the 12 months preceding the date of this Offering Document.

Notably, certain recent developments include:

- On December 29, 2024, the Company announced the appointment of Blaine Bailey as the chief financial officer and Priscilla Ikani as controller.
- On May 15, 2024, the Company announced the extension of certain outstanding share purchase warrants.
- On June 24, 2024, the Company announced the initial results from the 2024 surface exploration program at the Tombstone Project.
- On July 2, 2024, the Company announced the second batch of results from the 2024 surface exploration program at the Tombstone Project.
- On July 16, 2024, announced the results of reconnaissance surface sampling at the Tombstone Project.

The net proceeds from the Offering will be used to fund the Company's phase I reverse circulation (RC) drill program at the Tombstone Project (including ongoing joint-venture expenses), to fund ongoing expenses at the Cervantes Project and for general working capital and corporate expenses.

The above noted allocation of capital and anticipated timing represents the Company's current intentions based upon its current knowledge, present plans and business condition, which could change in the future as its plans and business conditions evolve. The most recent audited annual financial statements and interim financial report of the Company included a going-concern note. The Company is still in the exploration stage and the Company has not yet generated positive cash flows from its operating activities, which may cast doubt on the Company’s ability to continue as a going concern. The Company’s ability to continue as a going concern is dependent on the ability of the Company to raise equity capital financings, exploration success, the attainment of profitable operations and the completion of further share issuances to satisfy working capital and operating needs. However, unless and until the Company’s operations begin to generate positive cash flow, the Offering is not expected to affect the decision to include a going concern note in the Company’s next annual or interim financial statements.

FEES AND COMMISSIONS

The Company has not yet engaged any dealers or finders in connection with the Offering. The Company expects that a majority of the funds raised pursuant to the Offering will be sourced through third party registered dealers and other finders. The Company expects to pay a finder’s fee equal to a 7% cash commission on gross proceeds raised from purchasers introduced to the Company by eligible finders and finder warrants (“**Finder Warrants**”) in an amount of 7% of the total number of Units sold to purchasers introduced to the Company by eligible finders, with each Finder Warrant entitling the holder to purchase one Common Share of the Company at an exercise price of C\$0.18 for a period of 24 months following the Closing Date.
